STEP 1: Learn the requirements for submitting an application

Eligibility Requirements

- Egyptian citizenship; holders of U.S. green cards and/or passports are ineligible
- Applicants must reside in Egypt starting from the application process and throughout the selection, placement and pre-departure processes.
- Professional and academic staff in the field of Arts Management, museum and heritage studies holding an academic position at an Egyptian university or managerial/administrative position at an artistic institution e.g. museum, library, arts, cultural center/institute, etc.
- B.A./B.Sc., MFA or Ph.D.
- Excellent command of English.
- Applicants have to successfully complete all the steps of the assessment and selection process and successfully finalize all required procedures.
- The following persons and their immediate family members (i.e. spouses and children) are ineligible to apply during and for a period ending one year following the termination of such employment: employees of the U.S. Department of State; local employees of the U.S. missions abroad who work for the U.S. Department of State and/or the U.S. Agency for International Development (USAID); employees at organizations implementing exchange programs for the Bureau of Educational and Cultural Affairs at the Department of State; as well as Board Members or staff of a Fulbright Commission or their families (up to fourth kin).

Preference will be given to applicants without significant recent experience in the U.S. and/or overseas.

Important: The Fulbright Egyptian Scholar Program seeks applicants that have developed a sense of personal integrity and are original thinkers. Copying someone else's writing, whether from the Internet, from a book or from a friend is considered **plagiarism**. Any quoted words or sentences should include a

citation. An applicant who is found to have plagiarized in any form (including unintentional or accidental plagiarism) in his or her application will be disqualified. - Three reference letters:

You are required to provide three references. Please refer to the application instructions for guidelines on the submission of references. Reference letters can be provided through one of the following means of submission:

1. Having your selected referees submit their reference letters on-line through the **Register Recommenders** section of the on-line application.
2. Having your selected referees fill out and sign a **Reference Form**. Applicants must submit hard copies of the recommendation letters in **sealed envelopes** to 21 Amer St., Al Messaha, Dokki, 12311, Giza, Egypt **in person** before the program's deadline. For a copy of the form, please refer to pages 3 and 4 of this document. Please note that both pages of the reference form must be fully completed by your recommenders.

Note: Supplemental documents such as certificates and reference letters should be in **English** or with certified translation. All supplemental documents are to be scanned and directly uploaded to the application on-line system, except for hard copies of reference letters which are required to be submitted in person at the Fulbright Commission office.

STEP 3: Submit your application
